*Tuition Balance is based on the 2022-2023 Published Tuition per student with any applicable tuition discounts.

3) **Available Tuition Discounts:**

- **One Payment discount:** 2% on the remaining balance after all other applicable tuition discounts have been applied.
- **Large Families:** May be eligible for a sibling discount
- **Active Parishioners:** Parishioner of the Church who participates in the faith life of the parish by giving fully of their time, talent, and treasure and by regularly attending Sunday Mass and Holy Days of Obligation may be eligible for financial assistance.
- **Active Member:** Please see attached PIP Addendum and **sign here** that you have read and understand the addendum. _____
- **Financial Assistance Program:** Parent/guardian is responsible for completing the online FACTS financial aid application by Friday, April 22, 2022. Application link can be found on ILS website. Students currently receiving financial aid **MUST** re-apply for financial aid yearly.

In addition, I agree that a \$100 late fee will be assessed for tuition payment after the due date and \$50.00 fee will be assessed for check(s) returned from the bank marked "INSUFFICIENT FUNDS", and two (2) returned checks will place the account on a cash basis only.

At the end of each quarter, parents with past due tuition/fees balance will be notified by the school finance office of the past due amount and the minimum payment required. If all financial obligations are not current, the school will:

- Not allow the student to take mid-term/final exams.
- Block the online grade view for both the student and parent.
- Not issue report cards, diplomas and/or transcripts.
- Disenroll the student from the school.
